
Memo no. 1178Dated 17/05/24**BUILDING SAFETY CERTIFICATE**

Certified that the existing building of Akal Academy Ranno Village Ranno, P.O. Bhadson, Tehsil Nabha, District Patiala, Punjab owned/occupied by The Kalgidhar Society Baru Sahib have compiled with the Building safety requirements in accordance with National Building code Rules, and verified by the officers concerned of P.W.D Branch Nabha on 17.11.2021 in the presence of Ms. Kushma Rani (Principal) and that the building/premises is fit for occupancy upto classes (VIII) for a period of 5 years in accordance with rule and subject to compliance of the specific conditions as appended.

The inspection of the above said school's building by this office and this building was found safe for the year 2021-26, but special attention should be given on the following instructions:-

1. The water should not be allowed to stand around the building and on the roads.
2. If any part of the building is exposed to any kind of cracks, the area should be vacated immediately and repaired immediately.
3. That the material used in the construction of the building shall be the responsibility of the concerned school.
4. A part from the attached map, if any additional construction is to be done by you, then its approval should be taken from the department.
5. Rs.50,000/- for 5 years and Rs 2000/- Inspection fees has been deposited by the school through D.D.No. 951916 dated 07.09.2021 and D.D No. 951917 dated 18.09.2021 respectively.
6. If any additional construction is to be done by you in coming year 2021-26 without any intimation to concerned department than the above issued building safety certificate will be cancelled by the department without any notice. The school shall be responsible for this.
7. Here you are also instructed that you will be obliged to get the fire safety certificate of the building from the concerned department every year at your own expense. If any kind of incident happens in the building then this department will not be responsible for this.
8. If there are any instructions from the government regarding new fees, then the school management will be bound to follow those instructions.
9. In the future during the audit if any balance/liability arises against your school, you will be bound to deposit the balance/liability at this office and will not make any claim/litigation in this regard.
